PortfolioNet™ allows you to view all of your assets and perform custom, in depth analysis, and to generate standard or personalized reports. It is a PMS (Portfolio Management System) linked to a database that we update daily with your asset data.


PortfolioNet™ is in a way, the visible part of our service, the invisible part is the state of the art secure data management centre in Zurich. There, more than 20 experienced employees are responsible for processing and inputting your asset data everyday.

Each day we receive the relevant notices for all previous day's transactions, by mail or via a data feed. The employees then retrieve this information and update the database.

Once data is processed, all of your assets are updated and available for any required analyses with just a few clicks, regardless of the infrastructure of your financial partners.

With PortfolioNet™ you can detect and analyse the particular risks generated by the positions you have with various custodian banks. You will also identify potential conflicts of interest or contradictions that may arise between the strategies of your partners. You can finally see and assess the impact of your non-financial assets in your overall wealth.

All this with a few clicks, 7 days a week, 24 hours a day.




# INTEGRATED CONSOLIDATION

Unlike some companies, we handle the entire chain of consolidation.


Each day, employees at the data management centre, collect, format and input the information so that you can access all of your asset data in an accessible, measurable and constantly updated format.

# FEATURES


Organized into a system of multiple selection criteria (client, portfolios, strategy, currencies etc.) PortfolioNet™ provides access to many account statements both on screen and on paper. From the valuation of a specific deposit to the consolidation of all accounts, the selection is done in a few clicks. A logical and intuitive structure allows easy navigation through the system (positions, transactions, graphics, performance, etc).

Here are some of the key features:

- Portfolio(s) valuation
  - Performance analysis (TWR + Modif. Dietz)
  - Performance attribution
  - Contribution to the performance by asset class and underlying
  - Value at risk (VaR) and ratios

- Projected cash flow
  - Capital movements

# VERSIONS

PortfolioNet™ comes in two versions:

- **PortfolioNet™ Private**

The "private" version provides access to all client portfolios and presents information in a consolidated manner (transactions, performance, deposits, summaries, graphs etc.).

- **PortfolioNet™ Professional**

The "professional" version, intended for managers, provides access to the accounts of several clients. It also contains features geared to portfolio management (performance analysis, statistics, management of mandates, compliance and access to many reports), all in a very functional form.

This version includes all the features necessary for the manager's daily work.

# MODULES

PortfolioNet™ Professional can be supplemented with two additional modules:

- **"The Screener" Module**


Provides access to the profile and rating of over 5,000 listed companies trading on 37 exchanges.

- **Compliance Module**

Provides access to definitions of individual and global restrictions and automatically controls them. In addition this module provides an OBA function (Ordinance on Money Laundering)
